



- In FY25, **Gibson Dunn** led the Ad Hoc Group bankruptcy counsel rankings with 7 mandates, all on behalf of secured creditors. **Davis Polk** followed with 6 total engagements, primarily representing secured creditor groups, while **Paul Hastings** recorded 5 mandates, spanning both secured and unsecured representations. **Paul Weiss** also logged 5 engagements, split between secured and unsecured creditor groups.
- In FY25, **Porter Hedges** led the Ad Hoc Group local counsel rankings with 5 secured and 3 unsecured group engagements, totaling 8. **Howley Law**, **Morris Nichols**, **Pashman Stein**, and **Potter Anderson** each secured three engagements.

- In FY25, **Holland & Knight** topped the bankruptcy counsel league table with 16 lender/agent/indenture trustee mandates, all secured, followed closely by **Norton Rose Fulbright** with 15 mandates, primarily secured. **Foley & Lardner** and **ArentFox Schiff** placed on the third and fourth places with 14 and 13 mandates, respectively.
- For local counsel in FY25, **Young Conaway** led the rankings with 10 secured engagements, followed by **Potter Anderson** with 9, while **Morris James** and **Richards Layton** tied next with 8 secured mandates each.

BankruptcyData also indexes all disclosed contact persons and advisor team members. According to court filings, this year:

- **Goldberg Weprin's Kevin J. Nash** and **Pachulski Stang's Bradford J. Sandler** were among the busiest partners on the lead counsel front, while **John F. Higgins** of **Porter Hedges** and **Eric J. Monzo** of **Morris James** were the most retained local counsel.


